



## Supplier Fact Sheet

### About the Program

The Program supports community clubs in the ACT to undertake energy efficiency upgrades, building envelope improvements and install rooftop solar and energy systems to reduce their electricity and gas bills. Where clubs transition from gas appliances (hot water, cooking and heating systems) the project delivers significant environmental outcomes.

### Eligibility

Eligible community clubs are ACT clubs and club groups that currently operate, or have previously operated, gaming machines under a Class C gaming machine licence prior to 1 July 2021. Each club premises will be considered an individual club provided they hold a Class C gaming machine licence or have been granted an authorisation certificate for Class C gaming machines.

The items included in the following list will be eligible for installation by the Entity. These items will be recommended as part of the Energy Assessment Report (EAR) which must be approved by the Program technical assessor prior to commitment towards any installation.

#### Category A

*(generation and storage products and their installation costs)*

- Rooftop solar photovoltaic systems
- Battery storage systems

#### Category B

*(replacement of gas or inefficient electric appliances and their installation costs)*

- Electric heating and cooling systems
- Hot Water Heat Pumps (HWHP)
- Efficient electric stove tops
- Lighting systems
- Insulation and sealing

*Please note: See Section 6.5 of the Program Guidelines for mandatory product/system installation requirements.*

### The rebate

The Program will provide rebates to eligible community clubs capped at \$75,000 per eligible entity on a co-contribution basis. Large clubs will be required to invest \$3 for each \$1 of government support, and small and medium clubs will be required to invest \$1 for each \$1 of government support. Club size will be determined based on energy spend for each premise.



### General information

We encourage you to provide Program information to eligible clubs within the ACT. Please note the following when doing this:

- Rebate eligibility is determined on a case-by-case basis by the Program technical assessor therefore we ask that you do not confirm rebate eligibility with clubs.
- The quote provided to the club must not include any indicative rebate figure related to the program.
- If assisting clubs with Program paperwork, including completing and submitting forms on their behalf, clubs must sign all documentation where required. Please see Section 6 of the Program Guidelines which details processes and steps to be followed.
- The itemised quote to the club must:
  - include all the relevant approvals, components, and upgrade costs applicable to the premise.
  - Include specifications of the equipment to be installed (make, model, major specifications, etc).
  - Be compliant to relevant Australian standards and must include the return on investment, annual energy and cost savings and warranty related information.
- The quote must be submitted with the Pre-approval Form to the Program administrator to ensure the upgrade is eligible for the rebate.
- The Pre-approval Form must be approved prior any work commencing. Clubs will be ineligible to claim a rebate if they have accepted a quote, paid any deposits or made any commitments for purchases prior to obtaining approval from the Program administrator.
- Clubs are encouraged to obtain quotes from multiple contractors and will determine the most suitable options for their premise.
- The transaction between you and the club is independent of the ACT Government. The Program requires relevant safety standards to be met however we play no part in warranting the upgrades, ensuring quality of workmanship, etc.
- You must not use any ACT Government branding with your advertising material including hardcopy, electronic (email), website and social media platforms.
